



## 2010/2011 MEMBERSHIP AGREEMENT

### RIGHT TO CANCEL

The undersigned acknowledges the expressed desire to be a member of **Chicago Magic Soccer Club**. You may cancel this contract by notifying the Chicago Magic in writing before midnight of the 30th day after the date of this contract. In the event of such a cancellation, all registration fees paid will be refunded with the exception of a \$100.00 per person administrative fee. Players for the Chicago Magic are registered with the Illinois Youth Soccer Association and/or US Club Soccer, and are issued a players card and are not permitted to change their club affiliation before the end of the season. IYSA cards only pertain to the outdoor session of play (i.e.: the Fall and Spring sessions) and US Club cards pertain to indoor session only (i.e. Indoor I and Indoor II). . An administrative fee of \$100.00 per player is assessed for a release from the Chicago Magic before the end of the season.

### FEES, MEMBERSHIPS AND PAYMENTS

All fees for registration and/or other items or programs are payable in full upon demand. Late payments and payments by non-sufficient funds checks or credit card charges are subject to additional fees to the registrant pursuant to the Rules and Regulations of the Chicago Magic as amended from time to time. Should all sums due not be paid when due, registrant agrees to and shall pay any and all cost of collections, including but not limited to reasonable legal fees.

### ASSUMPTION OF RISK, RELEASE & INDEMNITY

The participant acknowledges that soccer or any sporting event is an extreme test of a person's physical and mental limits and that participation in a soccer event can cause serious injury. With a full understanding of the potential risks, the participant hereby assumes the risks of participating in a soccer event. As such, the undersigned agrees that he or she understands and voluntarily accepts this risk and agrees that Hallmark SportsClub, d/b/a Chicago Magic Soccer Club will not be liable for any injury, including and without limitation, personal, bodily or mental injury, economic loss or any damage to the undersigned, the undersigned's spouse, guest or relatives resulting from the negligence or other acts of the Chicago Magic. If there is any claim by anyone based on any injury, loss or damage described here, which involves the undersigned, any other member under this Agreement, any of the undersigned's non- member children or any guest or child which the undersigned or any member under this Agreement, the undersigned agrees to hold harmless Hallmark SportsClub, d/b/a Chicago Magic Soccer Club and indemnifies all expenses relating to the claim and obligations resulting there from.

### MEDICAL EXAMINATION
